WHEREAS, Middlesex County STEM Charter School's facility does not offer an adequate space for full scale physical education classes, and

WHEREAS, Middlesex County STEM Charter School desires to rent the Raritan Bay Area YMCA's facility for its physical education classes; and

WHEREAS, the Raritan Bay Area YMCA has an appropriate and adequate space and interested in renting it out to Middlesex County STEM Charter School; and

WHEREAS, the Raritan Bay Area YMCA is also interested in providing transportation from and to the Middlesex County STEM Charter School facility; and

THEREFORE, RESOLVED, that, the Board approves the agreement between Middlesex County STEM Charter School and Raritan Bay Area YMCA for renting the Raritan Bay Area YMCA facility for physical education classes in the amount of \$9,000.00 and using the transportation services in the amount of \$100/day throughout the school year 2018-19.

WHEREAS, Middlesex County STEM Charter School desires to purchase meals for its school food service program from Central Jersey College Prep Charter School; and

WHEREAS, Central Jersey College Prep Charter School has an adequate meal preparation facility and is willing to provide meals to Middlesex County STEM Charter School;

THEREFORE, BE IT RESOLVED that Middlesex County STEM Charter School enters into a School Food Authority to School Food Authority agreement with Central Jersey College Prep Charter School for the 2018-19 school year for the purposes of supplying food services through Central Jersey College Prep Charter School's contract with Maschios Food Services, Inc.

THEREFORE, RESOLVED, that the Board authorizes the Chief Education Officer to execute a car lease agreement in accordance with the provisions of N.J.A.C. 6A:23A-6.11 and 6A:23A-6.12. if Maschio's Food Services Inc. does not provide food delivery services from Central Jersey College Prep to Middlesex County STEM Charter School.
